Under the terms of the Data Protection Act and the Data Protection Directive this information will be treated in a secure and confidential manner. The Sandcastle Trust may be required to give some of this information – only where relevant and appropriate - to the bodies responsible for regulating and/or funding The Sandcastle Trust.

Eligibility Criteria

- The applicants must live in the UK.
- The applicants must have permanent legal residency in the UK and have lived in the UK for the last year.
- The organisation supports families whereby an individual or individuals have been diagnosed with a rare genetic condition (single gene inheritance, mitochondrial inheritance or chromosome disorder). The Sandcastle Trust defines rare as a condition that affects less than 5 in 10,000 of the general population. The diagnosis must be clinically evidenced.
- At least one of the following must also apply in relation to the individual(s) condition:

(i) it is degenerative

(ii) it is life threatening

(iii) it is life limiting

(iv) it causes severe, chronic disability or illness

(v) it results in complex health needs and/or learning disabilities that impact on their family's choices, ability to access social opportunities and enjoy family life.

(vi) It has had an enduring impact on your family life.

- Families who have suffered a bereavement as a result of a rare genetic condition are also eligible to apply.
- We do not accept applications for activities taken by individuals with a rare genetic condition on their own. The stated objective of the charity is to enhance the family life of those affected by rare genetic conditions and therefore the application must be for a family whereby an individual(s) in that family has a diagnosis. The activity must be for the benefit of that person together with members of their immediate family. Immediate family shall be defined as husband, wife, civil partner, partner, child, parent, guardian or sibling. Requests to include extended family will be considered on a

case by case basis and only in exceptional circumstances.

- In some cases the charity will consider requests from families affected by rare genetic conditions where the individual with the diagnosis will be not attending. The applicant family must demonstrate sufficient need with supporting evidence from a health professional that an activity that offers respite from their day to day caring role will have a positive impact on the entire family, including the individual with a diagnosis who will not be attending.
- The individual affected by a rare genetic condition must live with the family in the family home full time. If you share the care of any child named in the application with anyone else, (for example, the child lives half the time with their mother or half the time with their father) then you must notify The Sandcastle Trust of this.
- Any application in respect of a child in the care of the Local Authority, subject to a care order or living in foster care must be discussed with The Sandcastle Trust before an application is submitted.
- Access to support from The Sandcastle Trust is not means tested and you do not need to be in receipt of benefits to apply. However, we do ask for information on the household income in our application form. This is because all our grants are discretionary and subject to available funding. We may therefore decide to prioritise an application over another where a family has a significant level of household income
- The Sandcastle Trust can only consider one main grant application per family unless in exceptional circumstances, i.e. bereavement. Please contact The Sandcastle Trust if you believe this applies. This does not apply to any campaigns run by the Sandcastle Trust, for example, the Sandcastle Santa scheme. Families are welcome to apply every year to these schemes although funds are limited and

preference will be given to families who have not received support from The Sandcastle Trust before.

- The Sandcastle Trust can provide assistance to rare genetic condition patient groups, family support groups and small disorder specific charities to have 'meet-ups', 'away days', group family day trips and short breaks. The proposed activity or meet up should be family centred (as opposed to a charity information day/weekend).
- The Sandcastle Trust is a non-denominational charity and operates an equal opportunities policy. We are committed to achieving equality of opportunity as a grant making charity for families affected by rare genetic conditions. In considering applications we therefore aim to ensure that no family receives less favourable treatment on the grounds of any protected characteristic or for any other reason.

Terms & Conditions

- To be eligible to receive a grant the applicant family must meet The Sandcastle Trust's Eligibility Criteria (attached to the application form and available on The Sandcastle Trust's website).
- All the information provided in the application form must be accurate and not misleading. The Sandcastle Trust will take all necessary steps to re-coup funds expended and losses as a result of dishonest applications.
- Applicants should provide copies of all supporting documentation requested in the application form. Applications cannot be processed without this supporting documentation. Please do not send original documents as these cannot be returned.
- The applicant must advise The Sandcastle Trust of any changes in circumstance that may affect the application – for example, any changes in the condition of the person with the rare genetic condition, care arrangements, earned income or living arrangements including the death of the person with the rare genetic

condition or a child becoming subject of a care order. The applicant must notify The Sandcastle Trust of such changes as soon as they occur, whether they occur before or after the date of their application.

- The Sandcastle Trust may request that further information is provided in order to make a decision on an application. Failure to provide this additional information within a reasonable period will result in an application being declined and a full new application will be required.
- It is the responsibility of the applicant to take medical advice where appropriate, as to the suitability of the activity and the capacity (whether physical, mental or otherwise) of the person with the rare genetic condition to take part in it, all activities involved in it and all matters associated with it (such as, for example any travelling and accommodation which may be involved). The Sandcastle Trust is not qualified and will not provide advice in this regard.
- Any grant awarded should be used specifically for the purpose agreed between the applicant and The Sandcastle Trust during the application process and which will be detailed in the award letter that the applicant will receive if their application is successful. The Sandcastle Trust will take all necessary steps to re-coup funds expended and losses incurred as a result of dishonest applications.
- In accepting a grant the applicant agrees that they will comply with any specific terms and conditions that The Sandcastle Trust notifies them of in relation to the grant award.
- Any grant awarded by The Sandcastle Trust cannot be used in conjunction with an award from another charity or organisation.
- The Sandcastle Trust does not act as a travel company or tour operator. Families are advised to purchase suitable travel insurance for their break to cover all eventualities.

- Support from The Sandcastle Trust is discretionary and subject to available funding. There is no entitlement to a grant and all cases are assessed on an individual basis.

- Under the terms of the Data Protection Act and the Data Protection Directive the information you provide in the course of your application will be treated in a secure and confidential manner. Data Protection Statement

Who are we?

We, The Sandcastle Trust are a charity registered in England under the charity number 1169523. We are committed to respecting and protecting your privacy. Once you choose to provide us with personally identifiable information (any information by which you can be identified), it will only be used to support your relationship with The Sandcastle Trust. For your protection, we are registered under the Data Protection Act 1998.

What information do we collect and process about you and why?

We need to assess whether your family meets our eligibility criteria and whether we are able to offer you support.

To make this assessment we need to collect information from you as set out below via our postal application form and possibly via telephone and email:

- You and your family's (including any children) names, address, email address and telephone number;
- Details of your or your child's diagnosis, associated health implications, needs, mobility, level of understanding and behaviour together with information on the impact of the diagnosis on your family life;

- Copy supporting documentary evidence from a health professional confirming the diagnosis;

- Details of your household income including any benefits received.

We will use this information to determine whether we are in a position to offer your family support and to process your application. We may confirm receipt of, and keep you updated about the progress of your application via post, email or text message. You will have an opportunity to indicate if you have a preference about the way we communicate with you on your application form.

We may collect and process photographs and/or moving film images of members of your family following award of grant for the purpose of sharing stories and encouraging charitable activities. We will ask your explicit consent before collecting and/or sharing any photographs or moving images of your family.

How is the information we collect stored and how long do we keep it for?

We will store your personal information securely and guard against data theft. Your information will only be accessed by staff and volunteers who have received data protection training.

We discourage the retention of data for longer than it is required and will only keep the information we hold about you for as long as we need it for the purpose we collected it. This will be for a period of at least six years for audit purposes. All personal data will be deleted or destroyed by us in a secure manner after this date.

How to obtain a copy of the information we hold about you

To obtain a copy of the personal information we hold about you please write to The Sandcastle Trust, 66 Portnalls Road, Coulsdon, Surrey CR5 3DE. As soon as we are satisfied as to your identity we will send you, within 40 days of receipt of your written request, a copy of all the personal information we hold about you which we are legally required to disclose. Please contact us at the same address if you have any reason to believe that information we hold about you is inaccurate.

What third parties might we disclose information to?

If you receive a grant award from us then we will need to pass information about you to the relevant supplier(s) of that grant award. We will never sell or share your data with any other third parties unless required to do so by law.

Will you receive information about our services, marketing or fundraising?

When you submit an application to The Sandcastle Trust for support we will ask you if you are happy for us to contact you by post, email, text message or telephone to let you know more about other services, schemes or activities that you can apply for which may be of benefit to you and your family. We will also ask for your consent to keep you updated on what we are up to and ways that you can support our charitable aims as a potential donor, volunteer or fundraiser.
